Executive Director Report:

- 1. Notified Clemans Nelson Associates (CNA) that we will be terminating our retainer agreement with them and changing to a non-retainer agreement. Charge for retainer agreement is \$175/month. The non-retainer agreement allows for LORCO and CNA to maintain a business relationship whereby we can call and seek advice over the phone or through projects but the rates are higher and there are no included routine phone calls.
- 2. Sent welcome/introduction email to new commissioners and county administrator. Will be setting up a meeting to discuss some FPA and flow agreement issues.
- 3. 2018/2019 audit according to Auditor of State's office will now be ready "Late January".
- 4. NOACA board meets January 22nd. It is Lorain County's "turn" to have the board president position. According to Commissioner Moore, the Lorain County Commissioners have decided to continue with Commissioner Lundy to be on the NOACA Board. Commissioner Hung will also serve and Neil Lynch has been asked to be her alternate.

- 5. Still Meadows south side of Slife Road in Carlisle Township. Phase 1 is supposed to be on February planning commission agenda. 22 sublots. Entire project is approximately 60 sublots.
- 6. Eaton Crossings near IGA store on 82 in Eaton Township. 217 sublots. On this month's planning commission agenda.
- 7. Woods at Eaton still gathering construction bids. Plans to start in next 90-120 days. 52 sublots on Cooley Road.
