- That it is found and determined that all formal actions of the Board of Trustees concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board of Trustees, and that all deliberations of the Board of Trustees and of any of its committees resulting in such formal action were in meetings open to the public, in compliance with the law, including Section 121.22 of the Revised Code of Ohio.

Vote resulted as follows: 13 yea 0 nay. Motion carried.

Bob Smallwood provided board members with an in depth update of the status of the engineering on Phase I force main and collection lines. Currently 49 of the 55 miles of pipeline have been surveyed. The design plans are being updated with the elevations, property lines, existing utilities, and right of way information. Easement acquisitions and the permitting processes have begun and the easement descriptions are being prepared and forwarded to the LORCO office for preparation of easements. The Ohio Environmental Protection Agency will require wetland delineation to determine any negative impact during construction as part of our Permit to Install (PTI).

Attorney O'Toole stated he had hoped that funding would be completed and submitted to the USDA Rural Development office for approval but unfortunately it was not accomplished by the meeting. Further information will be forthcoming at the January meeting.

Administrative Assistant Haines reported that the NISC accounting software is working well and the November end of the month reports printed

without problem. During the next two weeks all 2005 information will be posted to the software and payroll accounting setup will be completed.

- That in anticipation of receiving permanent construction funding with a financing guarantee from the USDA/ Rural Development, the LORCO Rural Wastewater District may be required to expend or incur cost for planning and/or fees for the purpose of making capital improvements to their wastewater collection facility, which costs expended or incurred will be considered a part of the total USDA/Rural Development construction loan and the LORCO Rural Wastewater District may claim such costs as reimbursable expenses through the loan.
- That it is found and determined that all formal actions of this Board of Trustees concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board of Trustees, and that all deliberations of the Board of Trustees and of any of its committees resulting in such formal action were in meetings open to the public, in compliance with the law, including Section 121.22 of the Revised Code of Ohio.

Executive Director Alspach proceeded with the Administrative Report in which he reviewed the current bank balance, expenditures, time sheets and news articles.

Finance Audit Committee Chairman, John Piwinski, stated that the committee had met earlier in the evening with Mike Kiley, Senior Auditor with the

State Auditor's office to review the 2003 and 2004 audit findings. The final published report should be completed by the end of December.
