## **Approval of Minutes:**

It was moved by Koch, with a second by Roig to approve January 14, 2021 regular meeting minutes. Voice vote for approval was unanimous.

## **President's Report:**

Kurpely reported that the Executive Director had recently received a copy from the Lorain County administrator's office of a 2018 study completed by the firm KE McCartney for providing sanitary sewers to Columbia Township. LORCO was not contacted about the study and LORCO's collection system was not mentioned in the study as a possibility of receiving any flow from sewers proposed by KE McCartney for Columbia Township. The study proposed that all flow from Columbia Township be directed to the Northeast Ohio Regional Sewer District (NEORSD) collection system in northern Columbia Township. The study proposed to construct sewers that are in proximity to and, in some cases, redundant to LORCO's system. As LORCO was never contacted to provide data for the study and the study was apparently being completed by KE McCartney while negotiations were going on between LORCO, Avon Lake Regional Water, and Lorain County beginning in 2018 on a proposed sanitary sewer service agreement for a portion of Columbia Township, Kurpely recommends that a resolution be prepared for the March LORCO board meeting to rescind LORCO's previous approval of the proposed sanitary sewer service agreement. This agreement was never approved by Avon Lake Regional Water so it has never gone into effect. The board agreed with Kurpely that a resolution should be prepared and discussed at the March 2021 meeting.

**RESOLUTION NO. 2021-6 Approval of non-LMRE & RLCWA-related January deposits and payments.** It was moved by Berry, with a second by Roig to approve the resolution. Lynch asked a question about whether any cash payments are ever received from Phase 1 or Barrington customers. Toy answered. The vote was as follows: 15 Yeas. 0 Nays. Motion carried.

**RESOLUTION NO. 2021-7 Approval of RLCWA-related January payments.** It was moved by Koch with a second by Lahetta to approve the resolution. The vote was as follows: 12 Yeas. 0 Nays. Kurpely, Lamb, and Wesemeyer abstained. Motion carried.

**RESOLUTION NO. 2021-8 Approval of LMRE-related January payments.** It was moved by Koch, with a second by Berry to approve the resolution. The vote was as follows: 14 Yeas. 0 Nays. McConnell abstained. Motion carried.

**RESOLUTION NO. 2021-9 Reauthorization of Funds.** It was moved by Berry, with a second by Cornelius to approve the resolution. The vote was as follows: 15 Yeas. 0 Nays. Motion carried.
